Maintaining data integrity is more complex and critical now than it was a decade ago, thanks to the increased prevalence of computerized physician order entry (CPOE), EHR, EMPI and other clinical information systems. As more of these systems are interfaced, higher volumes of data flow between patient records and clinical, administrative and financial systems. An error at any point quickly snowballs as the information travels from one system to the next.

"It's not just a domino effect. It's exponential. Inaccurate data captured in one system can feed into as many as 50 others before it is detected ... if it ever is detected," said Just. "That is why Just Associates continues pushing its clients to higher levels of data integrity by delivering the innovative services necessary to ensure the information upon which care decisions are based is accurate, regardless of where it enters the system."
